

**RESOLUTION NO. 2010-\_\_\_\_\_**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA, AMENDING RESOLUTION NO. \_\_\_\_ RELATING TO THE DISPOSAL OF SOLID WASTE IN ALL INCORPORATED AND UNINCORPORATED AREAS OF WAKULLA COUNTY, FLORIDA; AMENDING THE DATE OF THE FINAL PUBLIC HEARING; DIRECTING THE PROVISION OF NOTICE THEREOF; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on June 21, 2010, the Board of County Commissioners of Wakulla County, Florida, (the “Board”) adopted Resolution No. \_\_\_\_, the Initial Assessment Resolution for Solid Waste;

**WHEREAS**, the Initial Assessment Resolution established a final public hearing date of August 16, 2010 and directed the provision of notice thereof to all affected property owners;

**WHEREAS**, the notices for the Solid Waste Assessment are going to be combined with the notices for the County’s proposed Fire Protection Assessment in order to save costs; and

**WHEREAS**, the public hearing for the proposed Fire Protection Assessment is being moved from August 16, 2010, to September 7, 2010, in order to provide additional time for citizen input;

**WHEREAS**, the Board now desires to amend the Initial Assessment Resolution for Solid Waste from the August 16, 2010, to September 7, 2010 to coincide with the proposed Fire Protection Assessment;

**WHEREAS**, given the potential public interest in the proposed Solid Waste Assessment and Fire Protection Assessment, the Board also desires to move the location of the September 7 public hearing from the Board’s chambers to the new Wakulla County Community Center;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA, AS FOLLOWS:**

**SECTION 1. AMENDED PUBLIC HEARING DATE.** Section 7 of the Initial Assessment Resolution for Solid Waste is hereby amended as follows:

**SECTION 7. AUTHORIZATION OF PUBLIC HEARING.** There is hereby established a public hearing to be held at 5:00 p.m. on ~~August 16,~~ September 7, 2010, in the ~~Board of County Commission Chambers, 29 Arran Road~~ Wakulla County Community Center, 318 Shadeville Road, Crawfordville, Florida, for the purpose of (A) receiving and considering any comments on the Solid Waste Service Assessments from affected property owners and (B) authorizing the imposition of such Solid Waste Service Assessments for Solid Waste management and disposal and collection on the same bill as ad valorem taxes.

**SECTION 2. AMENDED NOTICE DEADLINES.** Sections 8 and 9 of the Initial Assessment Resolution for Solid Waste are hereby amended to provide that such notices shall be published and mailed no later than August 17, 2010.

**SECTION 3. FULL FORCE AND EFFECT.** All other provisions of the Initial Assessment Resolution for Solid Waste shall remain in full force and effect.

**SECTION 4. EFFECTIVE DATE.** This resolution shall take effect immediately upon its passage and adoption.
